## 4. First-aid measures

<b>Inhalation:</b>	If symptoms are experienced remove source of contamination or move victim to fresh air and obtain medical advice.

## 5. Fire-fighting measures

Suitable (and unsuitable) extinguishing media:

**Suitable extinguishing media:** Use alcohol resistant foam, carbon dioxide, dry chemical, or water spray when fighting fires. Water or foam may cause frothing if liquid is burning but it still may be a useful extinguishing agent if carefully applied to the fire.

**Unsuitable extinguishing media:** Do not use water jet as an extinguisher, as this will spread the fire.

**Specific hazards arising from the chemical:**
